tlantic Health System has a long-standing tradition of providing exceptional patient outcomes and experiences. It is home to seven award-winning hospitals, including Morristown Medical Center, the No. 1 hospital in New Jersey according to U.S. News & World Report, Castle Connelly, and *Newsweek's* World's Best Hospitals. The system has also been ranked first in New Jersey in consumer preference by Monigle and first among health systems in the state as a "Best Workplace" by both *Modern* Healthcare and Fortune magazine.

#### Opportunity to Join Atlantic Health

In a newly created role, the Service Line Strategy and Growth Executive will be a critical addition to the Atlantic Health System (AHS) executive team at a time of great opportunity. This strategic thought leader will work with the CEO of the Hospital Division, market leaders, and other executives to develop, execute, and sustain strategic service line initiatives in support of advancing the enterprise's mission of building healthier communities. This executive will lead prioritization and execution of strategies to increase market share, improve access, and enhance patient experience across all service lines. From a network-wide vantage point, this leader will manage the assessment and development of new services and/or programs to increase customer focus, improve access, respond to the needs of the community, physicians and customers, enhance the AHS brand, and provide a competitive advantage for the organization in the external marketplace. As growth opportunities for key service lines are identified, this person will manage the identification and negotiation of joint ventures, potential M&A targets, and other strategic partnership opportunities.

The ability to build collaborative relationships, demonstrate strong, proactive thinking with a natural curiosity, coupled with proven success accelerating service line performance through cohesive strategic planning and execution, is critical for success in this role. Previous achievement of increased revenue, market share, and patient satisfaction will be important in taking Atlantic Health System above and beyond the nearly 1 million unique patients and continue to expand key clinical programs.

#### Atlantic Health System

Powered by a passionate workforce of more than 18,000 team members and 4,800 affiliated physicians dedicated to building healthier communities, Atlantic Health System serves more than half the state of New Jersey, including 11 counties and 4.9 million people. The system provides care for the full continuum of health needs across a wide array of settings, including 14 urgent care centers, Atlantic Rehabilitation Institute, Atlantic Home Care and Hospice, and Atlantic Anywhere's Virtual Visits. Facilitating connections between these services on both land and air is the transportation fleet of Atlantic Mobile Health.



Laser-focused on the opportunity to provide Alliance - a Clinically Integrated Network -

represents more than 2,675 healthcare providers throughout northern and central New Jersey. This

network includes 1,000 physicians and providers comprising one of the largest multi-specialty practices in the state – Atlantic Medical Group, as well as members of the Atlantic Accountable Care Organization and Optimus Healthcare Partners, which work to enhance patient care delivery. All ACOs had outstanding results in quality reporting under the Merit-based Incentive Payment System. In total in 2018, the ACOs saved Medicare \$9.6 million and over \$100 million since program inception.

This focus on access and affordability has resulted in the development of purposeful partnerships that have created new opportunities and value for patients. Atlantic Health is a founding member of the PIER Consortium – Partners in Innovation, Education, and Research – a streamlined clinical trial system expanding access to groundbreaking research across seven health systems in New Jersey.

#### **Transforming Care Models**

Atlantic Health System leads the Healthcare Transformation Consortium (HTC,) a collaborative of seven independent regional hospitals and health systems based in New Jersey, each with self-funded employee health plans, that share their expertise to address issues many businesses now face: how to improve access to high-quality health care for



covered employees and dependents while reducing costs. Members of the consortium include Atlantic Health System, CentraState Healthcare System, Holy Name Medical Center, Hunterdon Healthcare, St. Joseph's Health, Virtua and Saint Peter's Healthcare System. The member organizations have collectively bid out for third-party administration of their self-insured employee health plans. The group selected a single carrier with the aim of reducing administrative fees associated with providing healthcare benefits and providing more choice and access for the members and their dependents. The consortium selected Aetna, who partnered with the member organizations to develop a unique product that can be replicated by health systems in other regions.

HTC is committed to teamwork and is creating an innovative new model for health care delivery for New Jersey and beyond.

#### Innovation and Technology

Atlantic Health System is frequently recognized for the use of innovation and technology in care delivery and has just been named to the College of Healthcare Information Management Executives' (CHIME) 2019 Most Wired list in recognition of "meaningful clinical and efficient outcomes" and for embracing advanced technologies, such as telehealth, that expand access to care. In addition to leveraging the latest advancements in technology, Atlantic has built a culture of innovation embraced by team members

throughout the system. Atlantic Health Advancements (AHa!), a unique innovation center and idea incubator launched in November 2017, provides opportunities and a platform for every colleague at Atlantic Health to generate ideas that will enhance care delivery, improve clinical outcomes, and reduce costs.

Understanding the importance of educating and preparing the next generation of physicians and caregivers, Atlantic Health System is home to a regional campus of Jefferson's Sidney Kimmel Medical College (SKMC) at Morristown Medical Center and Overlook Medical Center. SKMC offers a Longitudinal Integrated Clerkship (LIC), a unique model of undergraduate medical education that reinforces continuity of care and patient-centered treatment unique in northern New Jersey. With more than 290 medical residents and fellows, and several technologist and technician certificate programs, Atlantic Health is training New Jersey's future healthcare professionals.

With a clear sense of purpose and unparalleled culture, Atlantic Health System attracts top leaders in the field of healthcare, from CEO Brian Gragnolati – who is the immediate past Chair of the American Hospital Association – to the numerous team members who serve as leaders across national clinical associations and research entities.

#### Hospitals

Featuring state-of-the-art equipment and comfortable, family-friendly environments, Atlantic Health System's world-class hospitals are on the forefront of medicine and continually set standards for quality healthcare in New Jersey and the New York metropolitan area.

Morristown Medical Center, a nationally recognized leader in cardiology, orthopedics, nursing, critical care, and geriatrics, is the only hospital in New Jersey named one of America's "50 Best Hospitals" for four consecutive years by Healthgrades. It is also rated the No. 1 hospital in the state by both *U.S. News & World Report* and Castle Connolly; named one of the



World's Best Hospitals (the 28th best hospital in the United States and No. 1 in New Jersey) by

Newsweek; and included on Becker's Healthcare 2019 list of "100 Great Hospitals in America." In addition, Leapfrog recognized Morristown Medical Center with an "A" hospital safety grade – its highest – eight consecutive times, and the Centers for Medicare and Medicaid Services awarded the facility its highest five-star rating in 2019. Morristown Medical Center is a Magnet Hospital for Excellence in Nursing Service, the highest level of recognition achievable from the American Nurses Credentialing Center for facilities that provide acute care services. It is also designated a Level I Regional Trauma Center by the American College of Surgeons and a Level II by the State of New Jersey.



Overlook Medical Center is home to some of New Jersey's top doctors, offering cutting-edge research, advanced technology and treatments in a compassionate, patient-centered environment. Its Atlantic Neuroscience Institute is the region's leader in the neuroscience care, offering a broad range of advanced neurological, neurosurgical, and

neurodiagnostic services. It is also certified as a Level IV Epilepsy Center and home to the Gerald J. Glasser Brain Tumor Center, where more brain tumor surgeries are performed than anywhere else in New Jersey. The CyberKnife® program is the largest and most experienced in the state, and a satellite emergency department in Union, New Jersey, treats about 40,000 emergency cases each year. In addition, Overlook Medical Center has advanced certification from The Joint Commission for perinatal care and is designated an Advanced Comprehensive Stroke Center. Additional Joint Commission-certified services include behavioral healthcare, spine surgery, wound care, and primary care medical home (PCMH).

Since 1932, **Newton Medical Center** has been providing care to the people of Sussex and Warren counties in New Jersey, Pike County in Pennsylvania, and southern Orange County in New York. It is home to the Center for Breast Health, the only one of its kind in Sussex County, addressing all of a woman's breast health needs with state-of-the-art technology,



resources, education, support, and follow-up care. Newton Medical Center recently achieved the American Nurses Credentialing Center's Pathway to Excellence designation and is one of a select few healthcare facilities in New Jersey accredited by the Intersocietal Accreditation Commission (IAC) in all three echocardiography procedures: adult transthoracic, adult transesophogeal, and adult stress.



Located in Pompton Plains, New Jersey, **Chilton Medical Center** is the top mid-sized hospital in the state, according to Castle Connolly Medical, Ltd. The Leapfrog Group gave the facility an "A" Hospital Safety Grade and it also earned the Lifeline Bronze Receiving Quality Achievement Award from the American Heart Association. In addition, The Joint Commission recognized

Chilton Medical Center as a Primary Stroke Center, it was awarded the American Heart Association/American Stroke Association's Get With The Guidelines®-Stroke Gold Plus Quality Achievement Award with Target: Stroke Honor Roll Elite, and it was recognized in 2020 with a Magnet nursing designation.

Hackettstown Medical Center has been providing care to the community since 1973, primarily serving Warren, Sussex, and Morris counties in New Jersey. From preventive services and outpatient testing, to care for minor injuries and life-threatening illness, it offers a wide range of services to keep the local population healthy. Hackettstown Medical



Center maintains several designations, including Primary Stroke Center from both the New Jersey Department of Health & Senior Services and The Joint Commission's advanced certification program; accreditations from the American College of Radiology for mammography, nuclear medicine, and ultrasound; sleep disorder center accreditation from the American Academy of Sleep Medicine; and Quality of Care recognition for the cardiopulmonary department from the American Association for Respiratory Care. In addition, education, screenings, support groups, and wellness programs for people of all ages are provided through the Center for Healthier Living.



Located on the campus of Morristown Medical Center and part of Atlantic Health System Children's Health, **Goryeb Children's Hospital** is a state-designated "Children's Hospital" – an earned recognition from New Jersey and the national Children's Hospital Association. With more than 250 community pediatricians on staff and more than 100 board-certified

pediatric specialists, it is northern New Jersey's leading specialized pediatric hospital and No. 1 in the state for the treatment of pediatric cancer. To meet high demand, Goryeb Children's Hospital is currently expanding its pediatric intensive care unit (PICU) and adding inpatient beds. These spacious private suites will feature the latest equipment and rooming-in accommodations for parents, as well as a dedicated pharmacy for improved safety and quality of care.

Named one of the nation's "Best Rehab Hospitals, Institutions & Facilities" by *Rehab Management* magazine, **Atlantic Rehabilitation Institute** is a joint venture between Kindred Healthcare and Atlantic Health System. The Institute provides a full range of services to restore the health and functional abilities of people after an accident,



illness, injury, or surgery. Whether at the inpatient facility in Morristown, New Jersey, or any of its outpatient locations throughout New Jersey, patients find the care they need to minimize pain, maximize independence, and improve their quality of life.

#### Atlantic Physician Enterprise

Atlantic Medical Group is a multispecialty physician network that provides high-quality, comprehensive medical care with more than 1,000 doctors, nurse practitioners, and physician assistants at more than 300 locations throughout northern and central New Jersey and Northeast Pennsylvania. The integrated physician network offers an efficient, coordinated patient care experience, as well as a state-of-the art electronic medical record system that provides patients enhanced, secure access to their medical data. Care is managed seamlessly among its comprehensive network of healthcare providers.

#### Atlantic Home Care and Hospice

Atlantic Home Care provides treatment and education services designed to prevent or postpone hospitalizations, and aid in recovery after a stay in a hospital or rehabilitation facility. One of the first hospices in the United States, Atlantic Hospice has been helping improve patients' quality of life and supporting their family members and caregivers in private homes, assisted living facilities, and nursing homes for more than 35 years.

#### Affiliations and Partnerships

Atlantic Health System is a member of AllSpire Health Partners, an alliance of seven hospital systems that addresses quality, population health management, best practices, and medical research in the Northeast region. Atlantic Health System also has medical school affiliation with the Sidney Kimmel Medical College at Thomas Jefferson University and is the official healthcare partner of the New York Jets.

#### Service Line Excellence

Many of Atlantic Health System's programs have received national accolades and designations, including Morristown Medical Center's orthopedics program – ranked among the top 35 in the nation by U.S. News & World Report, and Atlantic Health System's Cancer Care program – New Jersey's first and only National Cancer Institute National Community Oncology Research Program.

Additionally, Atlantic Health System Neuroscience at Overlook Medical Center, working with Atlantic Mobile Health, was the first in the nation to deploy and use portable telestroke technology in ambulances for routine pre-hospital assessment of stroke patients.

#### Morristown Medical Center - The Hub of Heart Care



Home to the largest cardiac surgery program in New Jersey and ranked one of the 30 best hospitals in the nation for cardiology and heart surgery by *U.S. News & World Report*, Morristown Medical Center's Gagnon Cardiovascular Institute serves as the hub of Atlantic Health System Heart Care.

Patients from Chilton Medical Center, Hackettstown Medical Center, Newton Medical Center, and Overlook Medical Center are seamlessly connected to Morristown when advanced cardiovascular care is necessary thanks to an infrastructure that includes helipads and ambulance transport and an electronic health record system that allows

physicians to share health records in real time. In addition, pediatric cardiology services are available at Goryeb Children's Hospital, located on the Morristown Medical Center campus.

#### World-Class Cancer Research

Atlantic Health System leads the fight against cancer with cutting-edge research. Atlantic Health Cancer Consortium (AHCC) is the first New Jersey-based National Cancer Institute Community Oncology Research Program (NCORP). Covering 73 percent of the state's population, the AHCC NCORP improves patient access to clinical trials focusing on cancer prevention, screening, care delivery, treatment, and quality of life.

In addition, physicians and healthcare professionals at Atlantic Health System Cancer Care participate in internationally recognized research for a multitude of cancers in more than 75 phase I to III clinical trials. Studies investigating the newest cancer treatments include:

- Tumor infiltrating lymphocyte (TIL) therapy for melanoma, head and neck cancer, and lung cancer
- The role of metabolism and first-in-class drugs (CPI-613) for stage 4 pancreatic cancer and other gastrointestinal cancers
- Novel small molecule chemotherapeutics for glioblastoma

Immuno-oncology treatments for HPV-associated head and neck cancer and lung cancer

With cancer ranking as the second-leading cause of death in New Jersey and the clear need to expand the availability of affordable innovation to the state's residents, Atlantic Health System opened the Breakthrough Oncology Accelerator in 2019. This partnership with the Translational Genomics Research Institute (TGen), an affiliate of City of Hope, and Origin Commercial Ventures created a new platform to deliver economically viable immunotherapies and other breakthrough cancer treatments to the region through expedited access and novel payment options.

Amy oversees Atlantic Health System's seven hospitals, including Morristown Medical Center, which has nationally recognized programs and is currently ranked the top hospital in New Jersey by *U.S. News & World Report*. She also develops and manages strategic growth initiatives for specialty service lines and more than 400 ambulatory and post-acute care service sites, creating additional points of access to connect with 1 million-plus lives per year.

Formerly Executive Vice President of LifeBridge Health and President of Sinai Hospital, Amy was the driving force in launching Sinai Hospital's BioIncubator, an innovation hub contributing to the growth of Maryland's regional biotech community. Most recently, she oversaw the November 2017 rollout of Atlantic Health Advancements (AHa!), which is designed to not only encourage ideas and accelerate innovation, but also inspire the team of more than 18,000 employees and 4,800 physicians to enhance care delivery, improve clinical outcomes, and reduce costs.

Her approach to tackling access and affordability has yielded surprising collaborations with those traditionally considered competitors. For example, Atlantic Health System's recent partnership with MedExpress now serves as a model of how the health needs of a community can be better served when former competitors work together to coordinate care.

Amy is also a great example of a strong and compassionate female voice making an impact in healthcare and shaping the industry. Becker's Hospital Review included her on its December 2017 list of 130 Women Hospital and Health System Leaders to Know nationally. *NJBIZ* named her one of the top healthcare leaders in New Jersey for 2018 and presented her with a Healthcare Hero Award for Innovation in 2019. Amy was also recently named one of *Modern Healthcare*'s Top 25 Women Leaders. This program honors female executives from all sectors of the healthcare system who are developing policy, leading change, and guiding healthcare delivery improvement across the country.



# Atlantic Health System Executive Leadership Team



# Position Description

his newly created position will lead initiatives for all service lines in support of advancing the enterprise mission of building healthier communities through performance, growth, population health and innovation, research, and education. As a strategic thought leader, this executive will evaluate and execute business development opportunities, identify and develop growth opportunities, grow key services and service lines, and assess strategic partnerships and market opportunities. In partnership with the Presidents of the medical centers, who are also known as "Market Leaders," the Vice President of Ambulatory Services, and Physician Enterprise leadership, this role is responsible for organizing business strategy and ambulatory initiatives that advance the Atlantic Health System agenda within specific markets, and overseeing the activities of the Executive Directors and Medical Directors who lead seven distinct service lines. Working in a matrix model, this individual will support the organization in the execution of specific business plans as well as the implementation efforts of system leadership teams, and act as a strategic growth advisor to AHS leaders.

The principal responsibilities of this key leader will include management of the assessment and development of the service lines to support the organization's efforts to respond to the needs of the community, physicians and customers; enhance the AHS brand; and provide a competitive advantage for the organization in the external marketplace.

#### Reporting Relationship

The System Service Line Strategy and Growth Executive will report to the CEO of the Hospital Division and Leader of Integrated Care Delivery and will have 14 direct reports to include dyad leaders for cardiac services, neuroscience, pediatrics, women's services, orthopedics, oncology, and medicine service lines.

#### Principal Accountabilities

- Utilize information and insights to advance Atlantic Health's strategic position through identification of growth opportunities, including opportunities for new sources of revenue, and/or threats to achievement of our initial goal of 1 million unique lives served annually.
- Provide strategic and operational support to service lines, including cardiovascular services, orthopedics, pediatrics, oncology, women's services, neuroscience, and general medicine services, and identify opportunities for service line efficiencies.
- Improve the market positions of the organization and support attainment of desired growth objectives. Work with market leaders, the Vice President of Ambulatory Services, and Physician Enterprise leadership to establish and implement service line goals. Ensure plans reflect growth while exceeding clinical, service line, and academic needs. Coordinate the implementation of plans and track progress.

#### **Position Description**

- Facilitate community and aligned physician relationships and integration in concert with system leaders, physician relations staff, and other network participants.
- Lead the implementation of regional growth initiatives; explore and negotiate joint venture initiatives.
- Provide professional development of direct reports and contribute to a learning and transformative Strategy and Business Development team.
- Understand the service lines and their specific market dynamics, including identification of potential market disruptors.
- Develop strategy and business plans to grow programs that are consistent with the system strategic plan and budget and achieve operational efficiencies in the programs overseen.
- Focus on patient outcomes while working with clinical teams to set clear expectations for quality priorities and track outcomes.
- Achieve financial and operational results.

#### **Experience and Qualifications**

In 2014, Morristown completed a new Moving Forward master plan to define its path forward: "to become the most welcoming, beautiful, healthy, resilient, and sustainable place to live, work, and play in New Jersey." Ninety-six percent of the town's 1 million square feet of retail space is occupied, mostly by small business entrepreneurs. Residents benefit greatly in that New Jersey does not charge sales tax on most unprepared foods, household paper products, medicine, and clothing.

For shopping enthusiasts, nearby Bridgewater Commons has 175 department stores, shops, and restaurants, along with a dine-in theater. Foodies will love the local farm-to-table favorite Urban Table in Morristown, serving up grass-fed beef burgers, locally sourced salads, and other farm-fresh dishes in a casual setting. Also popular is Hilltop Deli in High Bridge (featuring the New Jersey Sloppy Joe).

In addition to its historical sites, Morristown is rich in the arts. Arts and culture lovers should check out the Mayo Performing Arts Center, which pulls global talent to its stage. And there's the Morris Museum, home to the world-renowned Murtogh D. Guinness Collection of finely crafted, animated mechanical musical instruments and automata. The museum also houses the Bickford Theatre and presents award-winning performances for all ages.


#### Outdoors and Recreation

Morristown is connected to the beauty of the region by picturesque country roads. A short bike ride away are well-loved **Morris County Parks** such as Lewis Morris, the Traction Line Recreational Trail, and Loantaka Brook Reservation. The Great Swamp National Wildlife Refuge is close by as well.

Nature lovers will enjoy the **Fosterfields Living Historical Farm**, a 200-acre farm where you can feed chickens, collect eggs, use a washboard, and husk corn, all using turn-of-the-century methods. There are also farm animals, picnic tables, and The Willows, an 1854 Gothic Revival house built by Paul Revere's grandson Gen. Joseph Revere.

A short drive will take you to Sussex, where you can go up 1,803 feet to New Jersey's highest point. Hike some (or all!) of the 72 miles of the Appalachian Trail that stretch through The Garden State. Visit Lakota Wolf Preserve in Columbia to observe and listen to packs of wolves or tour Pequest Trout Hatchery to see where the public waters of New Jersey get their stock of more than 700,000 trout annually. The area offers some of the best outdoor activities in the state, with hiking, fishing, and camping in the warmer months, and cross-country skiing, snowboarding, and ice fishing in the winter.

Going down to the **Jersey Shore** is a popular summer tradition with mid-Atlantic residents from New York, Philadelphia and, of course, New Jersey. Busy city dwellers trade a subway for a beach cruiser and embrace a vacation of boogie-boarding, beachcombing, and cruising the boardwalk. While basic hotel accommodations are available all along the Shore, most visitors choose to get comfortable in a rented house, ranging from simple condos to beachfront mansions.



Morristown is in what is known as the **Skylands Region** and next to the Gateway Region of New Jersey. Home to High Point State Park—the state's highest point, naturally—the Skylands Region is where you can observe nature among rolling hills, river valleys, and forest trails.

When in New Jersey, the sports culture of super fans takes following the major league football, soccer, and hockey teams to a fanatic level. For a lower key and totally family fun experience, the minor league baseball teams bring out true fans of America's favorite pastime as well.
